2. Essentiality certificate is issued in favour of  
Guru Nanak Education Society, Village Gopalpur, Distt. Ludhiana  
for starting Ayurvedic Medical College subject to the  
following conditions:-

- (i) The Institute will get affiliation with the  
Concerned University before making admissions.
- (ii) The Institute will obtain recognition from the  
Central Council of Indian Medicine New Delhi.
- (iii) No admission shall be made without the prior  
approval of Punjab Govt. for which the institute  
will request the state Government.
- (iv) The admissions shall be done as per criteria  
fixed by Punjab Government from time to time.
- (v) The reservation of seats shall be as per Punjab  
Government instructions issued from time to time.
- (vi) The pay and emoluments of the staff shall be as  
per Punjab Government pay scales.
- (vii) The inspection of the institute shall be carried  
out on yearly basis upto the completion of the  
study of first batch of the students. Thereafter  
the inspection shall be periodical, after three  
years.
- (viii) The project is to be implemented as per the  
approved project report within the prescribed  
time.
- (ix) The applicant will deposit the earnest money  
of Rs. one Lac in the form of Bank Guarantee in  
the name of Punjab Government. This shall be  
forfeited in case the institute fails to  
comply with the conditions of N.O.C.

Sub: Grant of Conditional Permission to Guru Nanak Ayurvedic Medical College and Research Institute, Malerkotla Road, Gopalpur, Near Dehlon, Dist. Ludhiana-141118, Punjab for admission with 60 seats in UG (BAMS) course for the academic session 2020-21 under section 13A/13C of the IMCC Act, 1970- reg.

Sir/Madam,

I am directed to refer to the Ministry's letter with Ref. No. L-14014/77/2019-EP-1 dated 21.05.2019 related to admission matter for the academic year 2019-20, intimating certain requirements to be fulfilled by the college for consideration of permission for the academic session 2020-21.

2. Further, refer to the CCIM's letter No.Ref.4-66/2020-Ay.dated 24.11.2020 forwarding therewith recommendation of the college to the Central Government based on thorough examination of the visitation report Part-I, indemnity bond, affidavit & latest details of teaching, non-teaching and hospital staff submitted by the college along with the assessment report, as the physical verification by conduction of inspection could not be carried out in view of present COVID-19 pandemic situation for the A.Y. 2020-21. On examining the same, certain deficiencies have been observed and therefore, under provisions of the first proviso to sub-section (5) of Section 13A of the IMCC Act, 1970, an opportunity of hearing was granted to the college on 23.12.2020 to present the case through virtual mode.

3. The observations of hearing committee based on submission made by the college representatives during hearing, recommendations & assessment report of the CCIM and revised teachers status in respect of withdrawal of teacher's code dated 29.12.2020 have been carefully examined in terms of Regulation 3 of the “Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016”, provisions under the IMCC Act, 1970, relevant regulations made thereunder and it is found that the College is fulfilling notified and approved criterion for granting Conditional Permission for UG (BAMS) course.

4. It has, therefore, been decided by the Central Government to **grant Conditional Permission** to **Guru Nanak Ayurvedic Medical College and Research Institute**, Malerkotla Road, Gopalpur, Near Dehlon, Dist. Ludhiana-141118, Punjab for admission with **60 seats in UG (BAMS) course** for the academic session 2020-21 under Section 13C/13A of the IMCC Act, 1970, subject to the following:

- i. The fulfillment of conditions as specified in the Undertaking/Indemnity bond submitted by the college
- ii. The college shall submit an undertaking in form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations

5. It is further informed that minimum of 15% of undergraduate seats of the permitted intake capacity of 60 UG seats shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority of State/UT Government as designated by Central Government vide letter F.No.L.11011/02/2020-EP (1) dated 26.10.2020 for A.Y. 2020-21 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for all India quota or the students admitted thereunder.**

6. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under IMCC Act & Regulations made thereunder.

7. Discrepancies, if any, may be immediately brought to the notice of Board of Governors, CCIM and the Central Government.

8. As per clause 3(1)(a) of IMCC, MSR Regulations, 2016, the following requirements which are required to be fulfilled by the college by 31<sup>st</sup> December, 2020, will be examined for considering the permission for the session 2021-22:

- (i) all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
- (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
- (iii) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled *in toto*

9. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to CCIM under intimation to this Ministry. The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report along with its assessment in this matter to the Ministry of AYUSH for considering the permission matter from the academic session 2021-22.
